

Nevada's 2023 Comprehensive Support and Improvement Schools

Overview

Schools listed below have met the designation criteria for Comprehensive Support and Improvement (CSI) under Nevada's federally approved Every Student Succeeds Act (ESSA) Plan. The CSI schools list identifies schools eligible for supports and interventions. CSI schools also qualify for additional funding support through state and federal programs.

Eligibility Categories¹

CSI schools meet at least one of the following criteria:

- Title I schools in the bottom 5th percentile, according to their adjusted NSPF score index;
- High schools with a four-year adjusted cohort graduation rate (ACGR) below 67%; or
- Title I schools that did not exit an Additional Targeted Support and Improvement (ATSI) designation after three-year improvement plan.

CSI School Cohorts

Once a school is identified as a CSI school, it will remain a part of that cohort for a three-year improvement phase, with the goal of exiting CSI designation by not meeting CSI entrance criteria and additional criteria.² CSI schools were first identified in 2017, and the first exit evaluations (for schools designated in both 2017 and 2018) were done in summer of 2023. This year's CSI schools list includes schools that were identified in 2017 and 2018 and not exit in Summer 2023.³

¹ In accountability years prior to School Year 2021-22, schools that received a 1-Star rating on the Nevada School Performance Framework (NSPF) were automatically eligible to become a CSI school. Also, schools that were non-Title I but fell below the lowest 5th percentile cut were also designated for CSI. These categories have changed to better align with the accountability requirements under the Every Student Succeeds Act (ESSA). Schools that were designated previously based on these criteria still maintain their CSI status until evaluated for exit. In February 2023, NDE determined that all schools which were designated using those criteria should be removed from the CSI Designation list. The schools did not undergo an exit evaluation and were eligible to be redesignated as CSI in 2023.

² The three-year improvement plan is a change from previous iterations of the Nevada ESSA Plan where schools would be designated for a total of four years, a designation year followed by a three-year improvement phase. As a result of the change to a three-year improvement plan, schools designated in both 2017 and 2018 were evaluated for exit in summer 2023.

³ Schools designated as CSI in both 2017 and 2018 that did not exit are schools that are part of a More Rigorous Intervention (MRI) category. Schools in this category will be evaluated annually for exit.



Schools Meeting Comprehensive Support and Improvement (CSI) Criteria

Each of these schools were identified for CSI, in the year specified below, due to an index score in the bottom 5th percentile of schools, or a graduation rate below 67%. Graduation rates lag one year (i.e. 2023 NSPF graduation rates are based on class of 2021-22 rates), and rates as they are used in the NSPF are pooled over 2 years for schools with an n-size <10. School with an "*" are schools that are part of a More Rigorous Intervention (MRI) category.

Additional Information

Column Header Descriptions

School Number: The number used to identify schools. The number after the period indicates the school's level (.1 = ES, .2 = MS).

District: The school district of the identified school. Charter schools that are sponsored by the State Public Charter School Authority are listed as "SPCSA" while school district-sponsored charter schools are listed under their school district sponsor.

School: The name of the identified school.

Comprehensive Support and Improvement (CSI) Category: The CSI criteria the school met to be identified. To be identified as a CSI school, a school had to meet at least one of the following criteria: Title I schools in the bottom 5th percentile, according to their adjusted NSPF score index; High schools with a four-year adjusted cohort graduation rate (ACGR) below 67%; or Title I schools that did not exit an Additional Targeted Support and Improvement (ATSI) designation after a three-year improvement plan.⁴

Year Identified for CSI: Year school was designated CSI.

2023 Title I Status: Schools eligible for Title I funding are marked "Y" for yes or "N" for no.

2023 Star Rating: NSPF Star Ratings were calculated for 2022-23.

2023 Index Score (Out of 100): The total number of points, out of 100, a school earned in 2023. Details on how these points are earned can be found on the Nevada Accountability Portal.

2023 4-Year Grad Rate: The 4-year graduation rate included in the 2023 NSPF star ratings. Graduation rates in the 2023 NSPF reflect the graduating class of 2022. Data for schools with an n-size <10 was pooled over 2 years, and thus rates that are used for the NSPF may not match graduation data reported elsewhere.

⁴ No ATSI Schools have been evaluated for exit as of Summer 2023. The first year that Title I ATSI schools may be designated as CSI if they do not exit ATSI designations will be Summer 2024.
