## Access to Menstrual Products Report

The Access to Menstrual Products Report has been created in accordance with the regulation NRS 385A.315. The report has been meticulously compiled by gathering all the relevant information from the respective LEAs and presenting it in a single document.

## NRS 385A.315 Access to menstrual products

The annual report of accountability prepared pursuant to NRS 385A.070 must include, for each middle school, junior high school, and high school in the district and for each charter school that operates as a middle school, junior high school or high school, an evaluation of access to menstrual products.

District/School	Provide an evaluation of the access to and quality of menstrual products in the middle schools, junior high schools and high schools in the school district or charter school.
Carson City School District	In the Carson City School District all middle schools and high schools provide menstrual products that include sanitary napkins and tampons to all students in need, free of charge. They are located in all the health offices at each school.
<b>Churchill County School District</b>	The nurse's office at both the middle & high school have menstrual products; both tampons and pads for students to take as they wish. The office staff at the high school also has a supply in the event the nurse is out of the building. These products should be accessible and free in all girls' bathrooms at both schools.
Clark County School District	As a result of the passage of AB 224 (2021), in 2022, the Clark County School District (CCSD) Facilities Department purchased and installed menstrual product dispensers at each middle/junior high, and high school within the District. Each school received two dispensers, installed in locker rooms and multipurpose rooms. Additionally, menstrual products are also available in the school nurse's office. Quality menstrual products are purchased from reputable vendors required to meet specific industry standards. Any CCSD student attending a middle/junior high school or high school has access to quality menstrual products in multiple locations at no cost.
Douglas County School District	Our Custodial Services provides pads & tampons in free dispensers in all of our female bathrooms in all of our middle schools and high schools and our middle & high school health offices also offer free pads & tampons.

District/School	Provide an evaluation of the access to and quality of menstrual products in the middle schools, junior high schools and high schools in the school district or charter school.
Elko County School District	Menstrual products are available in each public school, free of charge and discrete.
Esmeralda County School District	During the Health Education Committee meeting, members will meet to discuss and evaluate the access and quality of menstrual products in the district. Information will also then be presented in Public Meeting to the Board of Trustees as a discussion item.
Eureka County School District	We are compliant at each school and supply free menstrual products at each school in two bathrooms and in the nurses stations.
Humboldt County School District	The district installed feminine hygiene dispensers at all middle, junior high and high school locations. Dispensers are located in "girls" restrooms. In addition, hygiene products are available in the school nurses offices.
<b>Lander County School District</b>	Dispensing feminine products (napkins/tampons) out of nurses' office at BMHS, ELJH, BMES. The school nurse purchases products of name brand (Tampax, Always) annually and as needed to serve to the females.
<b>Lincoln County School District</b>	All 4 of the schools in LCSD were evaluated to see if quality menstrual products for accessibly.
<b>Lyon County School District</b>	Menstrual products are readily available in every female restroom, ensuring easy access for students. Additionally, these products are accessible in the nurse's office for anyone in need.
<b>Mineral County School District</b>	Information required by NRS 385A.315 is not available for this entity.

Mater Academy of Nevada offers educational programs in fifth and 8th grade that raise awareness about menstruation and proper menstrual hygiene. This knowledge was crucial for reducing stigma and promoting a supportive environment where students understand the importance and accessibility of products. Mater Academy gathers feedback from students via exit tickets from presentations and conversations with students in the nurse's office. Mater Academy looked over the plan and ensured that they provide adequate support for menstrual hygiene and ensure that adequate facilities and products are available. Mater Academy has created a partnership with Project Marilyn that focuses on menstrual hygiene to enhance the resources available to students.
