Differences in Reporting for the Nevada Report card and Nevada's Accountability System (the NSPF)

The <u>Nevada Report Card</u> reports on Nevada statutory reporting requirements and expressed ESSA reporting requirements. ESSA requires states to count students differently across the state's Accountability System (the NSPF) and the State Report Card. Data associated with a school's star rating under the NSPF must be based on students who have been enrolled in a given school for at least half of the school year, and the rates exclude Recently-Arrived ELs for assessments and growth. The Nevada Report Card includes results for all students (it includes students who have been enrolled for less than half a year and it includes Recently-Arrived ELs). Comparing rates reported in the NSPF to rates reported within the Nevada Report Card can be problematic due to the differences between the sets of students included in the NSPF and Report Card. Some of the main differences are outlined below.

Chronic Absenteeism

District and School Chronic Absenteeism Rates as they appear on the <u>Nevada Report Card</u> include all K-12 students who were enrolled for ≥10 days. School and District rates are based on the days absent calculated for federal reporting (MDP codes are included in these calculations). The following table summarizes the differences between the NSPF and the Nevada Report Card:

A business rule change for calculating unduplicated state and district rates was introduced for the 2023-24 school year. In prior years, if a student showed up in the file at two, three, or more schools, the student record was duplicated within the file. The unduplicated rate that appears for 2023-24 combines those student records at the district and state level to ensure that students only appear once. This does lower the rates, and thus comparisons of 2023-24 and prior year's data should be done with caution.

Assessment Results

Assessment Proficiency results as they appear on the Nevada Report Card may or may not match NSPF business rules depending on the page. When looking at data that is broken down by Elementary, Middle, and High School levels, the data follows NSPF business rules (school level results follow the 95% participation rules outlined in the NSPF handbook). This includes the ELA and Math Proficiency results found on the "At a Glance" pages:

ELA Proficiency

Math Proficiency

When looking at the "At a Glance" page for the entire state, assessment results follow NSPF business rules except for YIS and YID (all students are included) and 95% participation rules.

When drilling into the data sets via the interactive "Data Interaction" pages found following the "Assessment Results" pages, the assessment results do NOT follow NSPF business rules.

Note that Federal EdFacts reporting also requires different Participation rules compared to those found in the NSPF. As a result, there are separate participation rules used/reported to the US Department of Education via EdFacts.

High School Science

One of the main differences between assessment results in the NSPF and the Nevada Report Card appears for the High School Science exam. The HS Science proficiency data on the Nevada Report Card does **NOT** bank prior year 9th grade results in the same way as the NSPF.

Due to the COVID Pandemic, the publication of the NSPF and the Nevada Report Card was disrupted.
